Brookfield – True to its contrarian investing reputation, on May 7, 2020, Brookfield Asset Management Inc. (“Brookfield”) announced the launch of a \$5 billion retail revitalization program. It is the kind of behaviour we expect from our investee companies, steeped in a culture of ownership, where founders and management teams have major ownership stakes. Instead of hoping for challenges to play out or demanding government bailouts, such companies take action. Brookfield’s program aims to focus on non-control investments in retail businesses to assist with their capital needs during this period of dislocation.
