**Silver Lake / Reliance Industries – On May 04, 2020**, Reliance Industries Limited and Jio Platforms Limited announced that Silver Lake will invest approximately USD753 million into Jio Platforms. This investment represents a 12.5% premium to the equity valuation of the Facebook Inc. investment announced on April 22, 2020.

The partnership with Silver Lake is a further endorsement for the Jio Platforms business, as Silver Lake is a known technology investor.

Its investments have included Airbnb, Inc., Alibaba Group, Ant Financial Services Group, Alphabet Inc.'s Verily and Waymo units, Dell Technologies Inc., Twitter, Inc. and numerous other global technology leaders.
