#### **BWXT Closes Acquisition of Kinectrics**

BWX Technologies (BWXT) has completed its acquisition of Kinectrics, Inc. (Kinectrics) as of May 20, 2025. Kinectrics is a Canada-based provider of engineering and in-plant services for nuclear facilities, operating globally with headquarters in Toronto.

This strategic move nearly doubles the workforce of BWXT's Commercial Operations and significantly expands its capabilities in both the commercial nuclear power and nuclear medicine sectors. Kinectrics, known for its lifecycle services for nuclear power plants and isotope production, will operate as a BWXT subsidiary. The acquisition strengthens BWXT's position in the global nuclear market, particularly in supporting CANDU reactors, small modular reactors, and the growing demand for medical isotopes.
